Kathleen Schnekenburger is our current Risk Management Official, replacing Laura on her maternity leave. She was previously in the role of regulations technician with the Conservation Authority and has now been promoted to Resource Planner. She will continue as RMO until Laura returns.

8. MECP Liaison's Update

Presented by Beth Forrest. There were twelve chair re-appointments across the province. The remaining seven were going through the new appointment process and were posted on the public appointment Secretariat. The posting has closed so we are now in the process of getting that information up to the Minister so that he can make his decision on those remaining seven chair positions.

Catherine Eby has moved on to another position. We are in the process of trying to figure out next steps. Right now, Mary Wooding and I will be filling in. I have asked

Conservation Ontario for a new staffing list for our branch due to the volume of changes in staff members.

There was a big change in the summertime, the Conservation Authorities file is being transferred back to MNRF from MECP. That file is leaving our branch along with the staff that were working on it.

There are no changes with the Source Protection program. The Best Practices for Source Protection document was released earlier this year. Its purpose was to address other systems that were not covered under the Clean Water Act. We have started a pilot project for these best practices for First Nations drinking water systems. We undertook outreach to Source Protection Authorities to find First Nations communities that have indicated an interest in source protection planning over the years. We will potentially fund 5-7 First Nations communities for source protection planning using the best practices document. We have selected 7 First Nations communities, most of which are in the north. We are currently working on developing transfer payment agreements to do that work from start to finish. We will keep you updated on this project.

The Ministry is still working on a number of Section 34 amendments and Section 36 updates. Interim progress reporting from a funding perspective is coming up at the end of November. This will be available for Katie very shortly. We are currently working on revisions to the questions in annual reporting. And lastly, we are working internally on a presentation that summarizes all the results from the previous reporting year.

Question: Tom – Katie has been very busy with the new threats table. Are all the other 19 committees doing the same?

Beth: To a certain degree, yes. Some committees completed their updates prior to the release of the latest adaptation of the Technical Rules so they will have to go back and align their updates to the 2021 version of the Technical Rules.

Katie: Yes, knowing that these policy changes were coming, I pushed our updating process back so that we could incorporate them. The project managers group is very collaborative and we are all sharing notes and helping one another.
