MECP LIAISON'S UPDATE

Olga Yudina, MECP Liaison provided a brief update to the SPC.

(1) The proposed amendments to the Directors Technical Rules are posted on the Environmental Registry (EBR) of Ontario. Katie will be covering these technical items in detail within her reports, but right now I'll outline more generally what our next steps are as it relates to the proposed amendments. The posting is currently on the EBR for 90 days and closes on November 9th, 2020. We welcome everyone to provide comments and encourage you to spend time digesting the information. Katie will outline how you can submit your own comments and also whether there will be a coordinated effort for gathering comments for submission by the committee as a whole. The MECP is going to review the submissions and consider all of the comments before proceeding. We are working on developing a guidance document to support the implementation of the changes to the Technical Rules, this has not yet been released. This guidance document will support the implementation

- of those changes once they are in effect. The expected decision notice posting to the EBR date, depending on feedback from the commenting period, is scheduled for some time in January or February 2021.
- (2) I also want to provide a little bit of an update on progress MECP is making in the development of *quidance documents for private systems* to ensure communities and individuals that don't have access to municipal drinking water systems have the tools they need to protect their sources of drinking water that are not covered under the Clean Water Act. This guidance uses existing source water protection information to provide a range of cost effect strategies to for the protection of sources of drinking water and how to manage the risks to drinking water. By using everything we learned under the Clean Water Act framework, this guidance will assist in the efforts to provide tips to these communities and individuals in the protection of their sources of drinking water. For example, it will include information and resources to help landowners ensure they have properly functioning septic systems, proper storage of on-site fuel tanks, pesticides, other sources of contaminants to make sure their drinking water is safe. The document will include information for municipalities on how they can use their existing regulatory tools to protect those private systems (e.g. planning act, municipal act, and septic inspection program). Right now we are consulting with a small representative sample of source protection authorities and municipalities. We have one or two project managers from each of the four regions in the province involved in the pilot stages to get some feedback on the guidance document. We've also reached out to municipal associations to identify representatives that could also be involved in reviewing the guidance document to determine how helpful it would be to communities. The MECP is going to incorporate all the feedback to finalize the guidance document. This document will be posted to Ontario.ca, and depending on the type of feedback received, it is scheduled for release sometime in the Spring of 2021.
- (3) The MECP continues to provide support to Source Protection Authorities, Municipalities and Committees with the amendments to their Source Protection Plans. Each Source Protection Area is in a different stage of working through their s.36 comprehensive review and update of the Assessment Reports and Plans. Since the approval of plans in 2015, there have been roughly twenty amendments to Assessment reports and Source Protection Plans. Depending on the complexity of this work and the changes, the Source Protection Areas have timeframes for completion of these updates and the MECP continues to provide support throughout the process.

OTHER BUSINESS

A few weeks ago, an issue was reported at the Arner Stop Gas station. This was initially reported as a natural gas leak, then confirmed to be a localized fuel leak. Due to older, compromised underground tanks, gas fumes were building up in the basement of the gas station. The immediate threat was a threat of explosion, not a threat of fuel leaking into the environment. The Fire Department confirmed that no fuel was lost to the environment and the Spills Action Centre (SAC) investigated and determined that it was not a threat to the environment or to our sources of drinking water, so they did not need to contact the water treatment plant operators.

This location is in close proximity to the Event Based Area and there was some confusion about whether there was a fuel spill, leading to some concern about contamination of nearby watercourses. We are confident that SAC followed the appropriate protocols, but this event has brought to light that we should consider developing a local procedure to share information about potential spills. This procedure should include notification that a spill has been determined *not* to be a threat to drinking water, particularly when information in the media is unreliable.
